Morrison reported that the 5/3 checking balance was \$950,874.25, 5/3 CDs were \$37,151.52 and \$3,601.70 and the Raymond James investment fund balance was \$230,469.25. Kopka motioned to accept the report as presented. Moerman seconded. Motion carried.

Morrison motioned to appoint Aaron Morehouse to fill a two year term on the Planning Commission Board. Pearson seconded. Motion carried.

The board set March 4, 2010 at 7:00 pm. for the public hearing on the 2010/2011 budget.

Road Repairs for 2010/2011

Corbin motioned to accept option #1 as presented by the supervisor for road repairs for 2010/2011. Pearson seconded. Motion carried.
