#### Lake Doster Water Problem

Currently the Township is experiencing a rusty water problem ranging from light to very heavy rust, depending on the day or time of day. Our water and sewer operator has been trying to resolve the issue for some time, however everything that Rook has tried doesn't seem to work. The following people voice their concerns regarding the ongoing problem with the water. Dan Bird at 24 Eagle Green Court, Diane Abbott at 32 Eagle Green Court, Janet Bird at 24 Eagle Green Court, Carol McBeth at 28 Eagle Green Court and Kevin Blue at 220 Phoenix Court. Tom Rook explained that your water is brought to you through groundwater source, the wells are located in the Midlakes Blvd area and flows in three directions to the water tower. Rook also explained that he does monthly samples and other state samples as required every three years and all EPA requirements are met. Rook also stated that he tests the water five days a week. The Township board had Dixon engineering to inspect our water tower for the integrity and condition of the tower. The report indicates that the tower is not the reason for the rust. Kopka suggested that we put a plan in place to try to once and for all clear up this issue for these residents. 1. Flush the area thoroughly as needed this week. 2. Upon Rook suggestion use a camera to go into the pipe to look for problem areas.3. If necessary the Township may have to cut the pipe and replace it. Board thanked the residents for being patient while we are trying to work through this problem. The board will communicate our progress to the above residents.
