#### Plainwell Schools

Melissa Gelbaugh was present to discuss the upcoming vote on the Allegan Area Educational Service Agency Proposal 11 Area Vocational Technical Education Millage Proposal Restoration of Hadley Reduction. Gelbaugh noted that this millage is very important to continue with a program.

## Sewer/Lake Doster

Vandenberg reported a sewer line collapsed at Lake Doster on LakeView Lane running down to Horseshoe Court. The quotes that we are receiving to prepare the list station, install new 1 1/4" poly from 336 Lake View to sanitary manhole, trench to be 5 feet deep. Trench backfilled with native materials, saw cutting as needed, remove/replace asphalt entrench area, re-seeding of disturbed areas, and 400 1f of 1 ½" poly, mobilization, install up to 100 1f of silt fence. The bid for this project is \$28,345.00. Vandenberg motion to approve the bid to fix and repair. Meert seconded. Kopka yes, Horton yes, Pearson yes, Shannon yes, Vandenberg yes and Meert yes. Motion carried.

#### 425 Midlakes

There is an area on Midlakes where water is pooling and causing flooding in some resident's yards and drive ways. Vandenberg contacted Allegan County Road Commission, they informed him that they could fix the problem, the costs could be up to \$3000.00. Vandenberg motion to table this issue until he has more details. Motion carried
