Bill Geresy asked the board for permission to honor the veterans with a simple ceremony at hillside in Woodside on Memorial Day. Morehouse motion to approve this honorary commencement. Shannon seconded. Motion carried.

New business

COVID - 19

Vandenberg stated that with Gov. Whitmore new extension until May 28, 2020 he would like permission to cancel the Planning Commission meeting. Vandenberg stated that in order to hold this meeting properly that all board members, guest or project managers would need to review the blueprints and go over the as plans for the property in question, which would not be possible with the 6 feet guidelines of separation for safety. The board agreed with Vandenberg to cancel the meeting.

Cemetery

Vandenberg stated that he would like to give Brian Burr a 2% raise. Meert suggested a 3% raise. Morehouse motioned to approve a 3% raise for Brian Burr. Shannon seconded. Meert yes, Morehouse yes, Kopka yes, Vandenberg yes, Horton yes, Pearson yes and Shannon yes. Motion carried.

Request to refund water fee

The owner of 1029 North Stoneridge has requested a refund because they will not be building this year due to the pandemic. Horton stated that the city of Plainwell has already reimbursed us their portion. Shannon motion to refund their money. Horton seconded. Motion carried.

Meert motioned to accept the bids from Smith and Sons in the amount of \$35,058.00. Shannon seconded. Motion carried.

Vandenberg explained that it we had a lot hail damage to our roofs and the adjusters will be meeting with Vandenberg on Tuesday to assess the damage.
